Class Curriculum

This is a special five day (36 hour) training program designed for Law Enforcement Investigators, Vice Units, Narcotics Units and Officers who participate in street level enforcement and undercover narcotics/vice investigations. Prostitution and narcotics activity are crimes that plague every city. This specialized conference will detail how to conduct undercover narcotics and prostitution reverse sting operations as well as officer safety techniques for decoy officers. Human trafficking is often associated with prostitution organizations. Illegal immigrants from all over the world as well as Americans are being forced into prostitution in every state. The conference will cover "Sneak and Peek" search warrants, which are utilized in massage parlor investigations. Case studies will detail the legal aspects of obtaining these specialized warrants and how to covertly install the technical monitoring systems. Following the money trail is essential to investigating vice related crimes. Investigators will also learn how to work and manage cases on Strip Clubs, Massage Parlors and Escort Services. The Tactical Narcotics Techniques theory will show Investigators how to conduct short term operations on area's plagued with narcotics and prostitution activity. Agencies will be shown how to set up and run undercover storefront locations for narcotics and vice operations as well as initiating and running long term street level narcotics investigations. Major narcotics reverse sting operations will be covered showing investigators how to target Drug Trafficking Organizations and how to seize illegal currency associated with these criminal organizations. Gang investigations involving fraud and identity theft will also be covered during the conference. This training offers new techniques and insight to both new and veteran investigators.
